ANNUAL DUES

MORE MUST-KNOW COVENANTS

Article IX, Section 6—Improvements and Alterations

No building, fence, wall, residence or other structure shall be commenced, erected, improved, or structurally altered, without the prior written approval of the Architectural Committee. The exterior surface shall not be painted (other than painting with the same color of paint as previously existed) or changed in any manner without the prior written approval of the ACC.


Article VIII, Section 10b—Landscaping and Lawns

Each owner of a Lot within Cherry Hills Subdivision shall keep all shrubs, trees, grass and plantings, including the area located between the boundary line of his property and the street on which such Owner's property abuts, **neatly trimmed**, **properly cultivated and free of trash**, **weeds and other unsightly material**. Owners shall keep a minimum of two trees, each tree minimum of 10 feet in height, in the front lawn of the Owner's lot...

Article VIII, Section 13—Trash Containers and Collection

No garbage or trash shall be placed or kept on any property within Cherry Hills Subdivision except in covered containers of a standard type approved by the Association. ... In no event shall such containers be maintained so as to be visible from neighboring property except to make the same available for collection and then, only for the shortest time reasonably necessary to effect such collection.
