

Changes to Trash Service

In June of 2019, our current trash provider, Ozark Mountain Santiation (OMS), informed our neightborhood and the POA Board about changes to monthly pricing (an increase of about 9%) and the discontinuation of optional curbside recycling. Neighbors contacted the POA Board to express both support and concern over maintaing OMS as our neighborhood provider.

Cherry Hills had used OMS for approxinately 12 years without a contract, so there were no procedures in place to deal with changes in service or pricing. The POA Board, in conjunction with the Board of Cherry Ridge (homes to the south of our subdivision) decided to solicit bids from area companies to compare prices and to see if optional curbside recycling might still be available. Both subdivisions worked together to solicit bids both to offer economies of scale to potential providers and to maintain consistent pickup days between neighborhoods.


Six providers were contacted and three responded with quotes. After evaluating the three quotes and the terms offered by OMS, the POA Board selected Queen City Disposal (QCD). In a seperate vote, the Cherry Ridge also selected QCD.

Both POA Boards have been in contract negotiation for the past few months to iron out the terms and conditions of the contract. The final contact draft was received this week and should be executed in the coming days.

Our new provider is 16% cheaper for solid waste removeal, offers optional curbside recycling, and is a locally owned and operated business. The Board thanks our neighbors for their patience during this switch over.

A summary of important information about the switch over is below:

- 1) Ozark Mountain Sanitation will pickup its last trash collection on Thursday, December 26. After the trash is picked up that day, OMS will come back and retrieve all trash cans and recycling bins. All homeowners should have received information about these procedures last week.
- 2) Queen City Disposal will deliver new carts during the first two weeks of December. They will provide a courtesy pickup on Tuesday, December 31 and normal service will begin Tuesday, January 7 and every Tuesday after that.
- 3) Information from our new provider is attached to this newsletter and details the pricing schedule, holiday schedule and other services.
